


AFT DELUXE













Description: AvFab's Aft Deluxe divan increases the length of the cabin and opens up the floorplan dramatically, all while increasing the maximum seating capacity. AvFab has the only FAA approved solution for spacing out the Citation cabin. Divan is delivered in "green" ready to be finished condition.

Model: 500, 501, 550, 551, Bravo, S550

Features:

- All seats individually recline 20 degrees
- Center Seat folds for easy access to aft storage
- Can be used instead of existing aft cabin seats
- Allows for 20 inches of storage space behind the divan

Approvals: Federal Aviation Administration Parts Manufacture Approval (PMA) and Supplemental Type Certificate (STC). This eliminates the need for field approval.

Installation: While the process is different for the different models, an estimated 80 hours are required. The kit includes all parts needed for installation including oxygen masks for the 3 passengers, air vents, hardware, quick-change components, placards.
