**Approval:** Federal Aviation Administration Parts Manufacture Approval, PMA, and Supplemental Type Certificate, STC, (eliminating the need for field approval).

**Features:** Kit includes stretcher base and cover, Ferno 12-1 portable litter, mattress, mattress cover (conforms to FAR 23.853 horizontal flame test), restraint system, installation instructions, and weight and balance data, etc.

**Installation:** Initial installation can be accomplished by simply removing the seats on the applicable side of the aircraft and sliding the stretcher on existing seat rails..

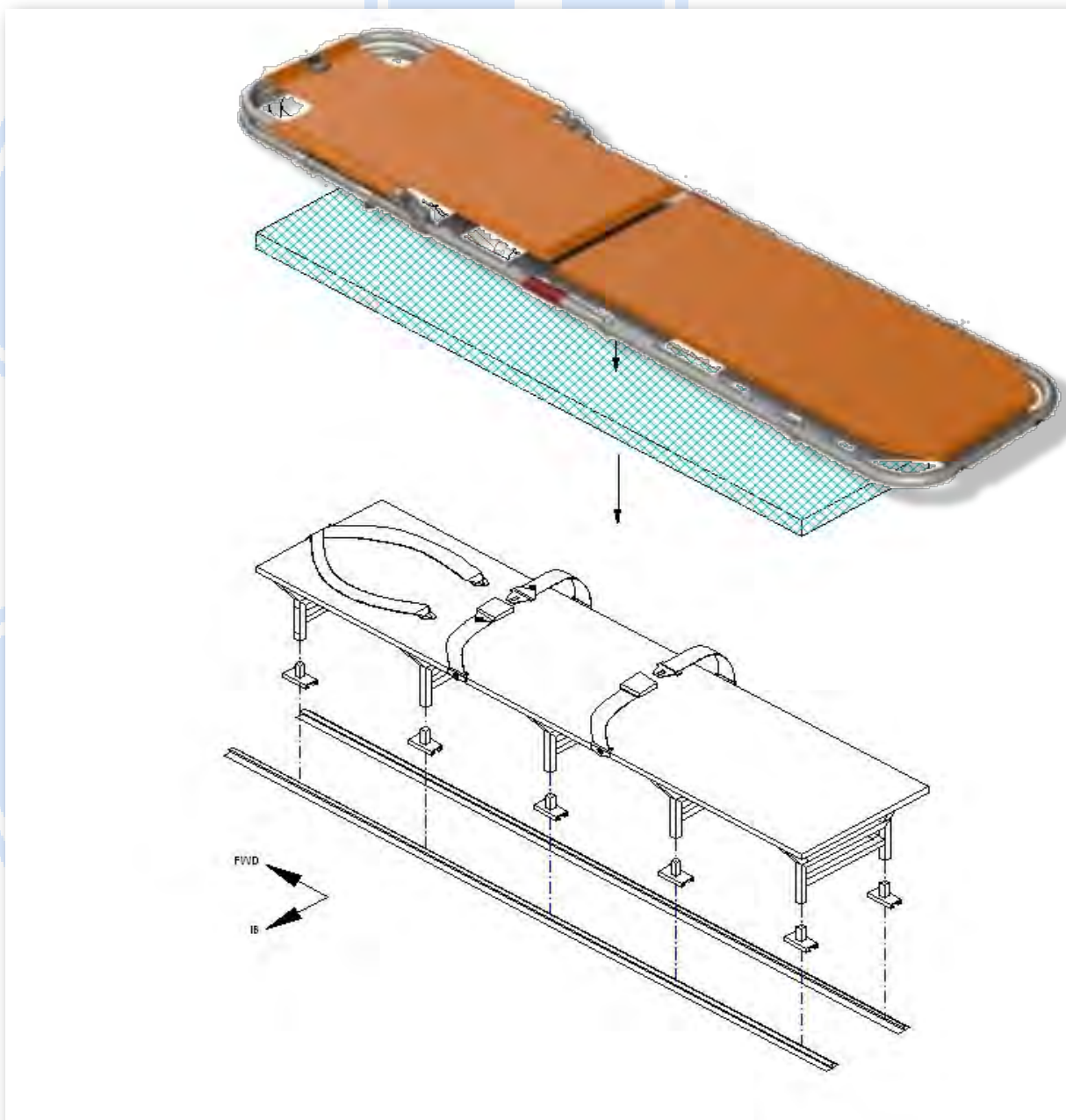

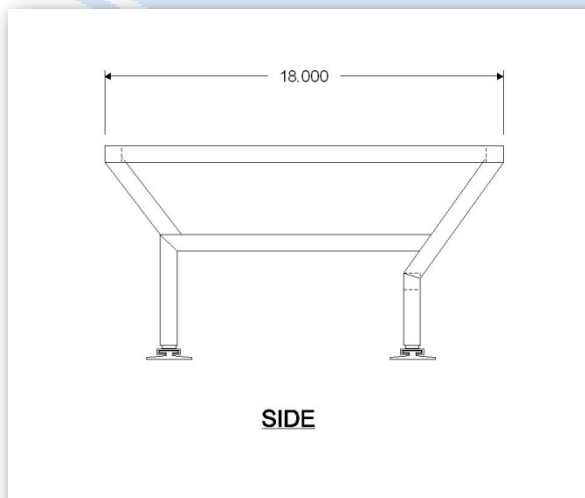
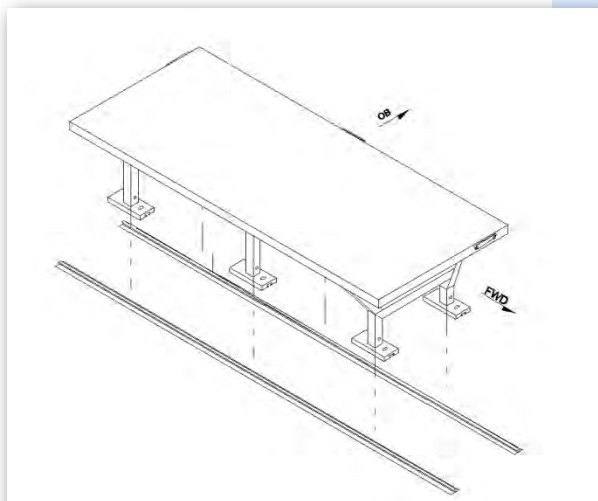

**Installation:** No airframe modification is required other than removing existing seat/s and furnishings, and setting the new stretcher assembly in the existing floor fittings which were vacated by the removed seats (complete installation instructions, diagrams, and weight and balance data are included in the kit).

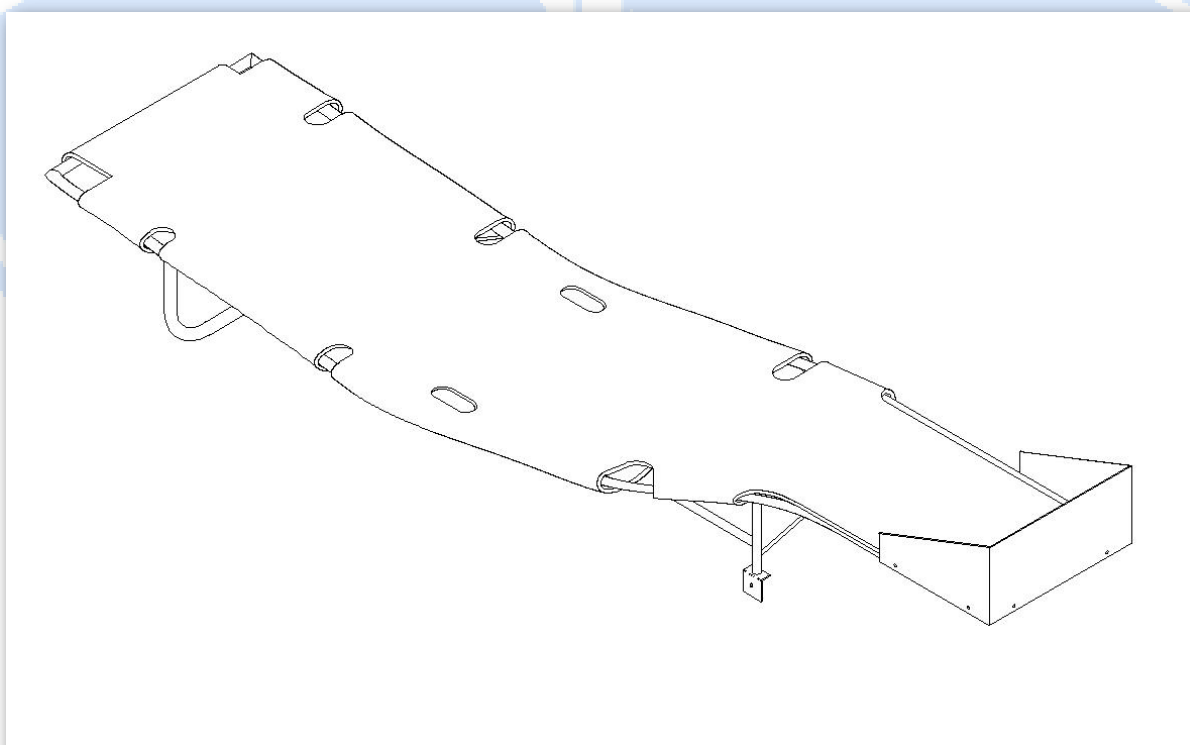
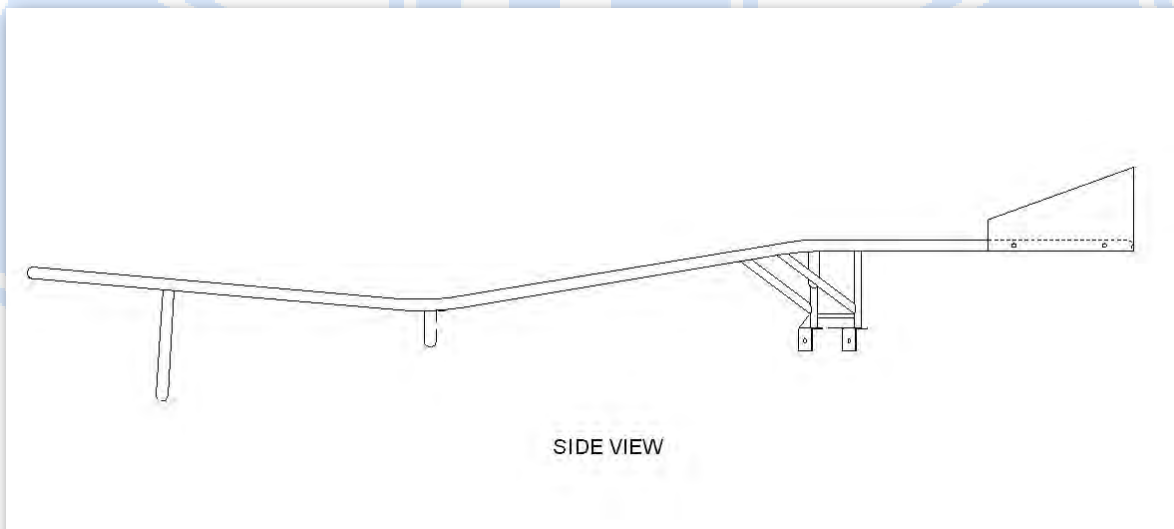
